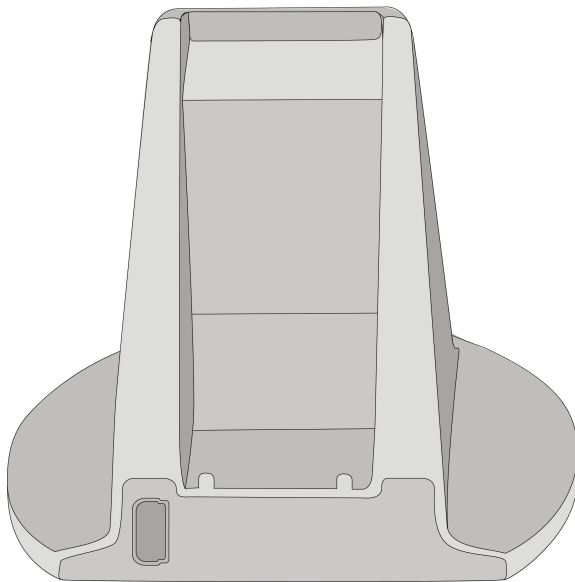


# INDUCTIVE CHARGER FOR SMART TWEEZERS™

## Inductive Charger for Smart Tweezers™

Model: STIC-1



### Introduction:

The STIC-1 Charger is an inductive charger for Smart Tweezers™ LCR meters.

NOTE: This product works only with Smart Tweezers™ ST-3i equipped with inductive coupling board and rechargeable batteries.



ATTENTION! Charge Smart Tweezers™ for at least 4 hours before first time use.

### Product Features:

- Full and trickle charging models.
- Integrated “Fuel Gage” timer.
- Protection against overcharging.
- Two-Colour LED indicator.
- USB interface can be used as power supply.

### Package Contents:

- Charging cradle.
- AC Adapter.
- This Manual.

### Operating Procedure:

1. Connect power supply to the cradle.
2. After a brief time in the cradle LED starts flashing GREEN.
3. Place Smart Tweezers™ ST-i3 unit into the charger slot.
4. Depending on the remaining battery capacity the cradle LED colour changes to a constant RED indicating the full charging mode, or remain flashing GREEN indicating a trickle charging mode.
5. It is recommended to keep the ST-3i in the charging cradle when not in use. The charger stays in trickle charging mode.

NOTE: Disconnecting power from the cradle is not recommended as it resets the “Fuel Gage” timer.



WARNING! Safety guidelines: Put clip provided with ST-3i to cover the tips before placing the unit on the cradle. Manufacturer is not responsible for any damage that occurs by not following this instruction.

### Warranty:

Limited one (1) – Year Warranty: Manufacturer Warrants this product to be free from defects in materials and workmanship (subject to the terms set forth below) for a period of one (1) year from the date of purchase (“Warranty period”).
